A BRIEF HISTORY

In 2024, it will be the 152nd Orange Agricultural Show, an event that has been part of Orange since 1873. But events have been held since 1855 which led to the formation of the Orange A & P Society.

The first function of the kind, a ploughing match, is said to have been held in 1854 at what is now the Five Ways, at East Orange. There is a record in the BATHURST FREE PRESS of 16th June 1855, of the holding of the Orange Ploughing Match on Moulder's property. Priest's bullock team-won first--prize.

In November 1855, a meeting was held to discuss the ploughing match and it was decided to award a prize for samples of wheat and other produce. The BATHURST FREE PRESS of 16th April 1856 refers to a meeting of the Orange Agricultural Association and T. J. Lane was in the chair. The 1856 match was held on J. A. Templer's ground (Narrambla) and the first prize for a home team was won by Jabez Priest, and he was awarded £10.

By 1861, it was more than a ploughing match as it included fruit & vegetable exhibits as well as horses, cattle, and pig's entries. It was hold opposite Peisley's Inn, now identified as the Victoria Hotel.

The five acres, between Kite and Moulder streets, fronting Lord's Place, was set apart "As a cricket ground," embracing ten acres, later became the showground, and later again Wade Park—after C. G. Wade. Premier of N.S.W.

As we are aware the early exhibits were held at several locations around the town before a semi-permanent home was found at what is now Wade Park in 1873. Shows continued to be held here for the next thirty-six years.

In 1895 the Committee approached the New South Wales Government to pass an Act to allow the Orange Pastoral and Agricultural Society to mortgage certain land to pay off buildings that the Association had erected. Finally in 1897 the colonial Government of NSW passed the '**Orange Showgrounds Act 1897**'.

In 1904, the grounds were becoming too small at Wade Park for the Orange Show and the Association discussed the problem on a regular basis. Finally, it was decided to purchase some forty-eight acres (at the current site.)

In 1908, Land was purchased in the Bletchington area, which is now the Orange Showground. The first show was held at this ground in 1909. This was the year the Showmen decided to strike after a disagreement between the Orange Show Executive and the showmen over “rates of rental.” The Showmen formed themselves into a union and threatened to stage a Showman’s Carnival on the Recreation Ground, the same grounds where the previous year’s show had been held. The Showmen left the grounds and held a meeting at the Exchange Hotel. Fortunately, on the morning of the second day of the Orange Show, after discussions were held, an amicable agreement was reached with the Show President Mr. Michael Dalton and Show Secretary Mr. Walter Tanner. Afterwards the Showmen returned to the showground reporting they were “patronized in a royal manner” over the remaining two days of the show. Many of the buildings were dismantled and removed to this new site and put back together in time for the 1909 show. Building began later this year on the grandstand and the pavilion however it would be four years before they were completed.

Some of the more notable events at The Showground during the Annual show were:

- 1912** First Airplane flight in Orange. Wizard Stone flew his Bleriot monoplane over the grounds much to the amazement of many and it was all eyes to the sky. The Grandstand and main Pavilion were completed in time for this 1912 Jubilee Show and were packed as the record crowd came to see the ‘new fangled attractions.’
- 1914** The 1914 Orange show was held before the outbreak of World War. The show continued throughout the war, but the showground was for by Light Horse units for training. The Dalton Pavilion was opened during this show.
- 1923** Orange’s Diamond Jubilee Show was held in what the Orange Leader newspaper described at the time as “unfavorable conditions.” A special rail siding had been established near the grounds though many walked to the new showgrounds. A steam train made regular trips between Orange and the ‘show’ siding.
- 1925** Local pilot Tom Linn crashed his aeroplane (Avro 504K) in a paddock next door to the showground on Wednesday afternoon 29th April, during a joy flight. Both Mr. Tom Linn and his passenger at the time Mrs Harriett Hickey, were killed.

In the mid 1930's Rural Youth Clubs or Junior Farmers' Clubs exhibited at many of the shows and was a popular organization taking up large areas in the Orange Show pavilion with their impressively designed and executed displays. In 1935 William (Bill) Pascoe, a local orchardist, became President of the Society and played an active part in lobbying local fruit growers to become involved with their local show. From this time Orange orchardists began to exhibit their locally grown fruit.

Leading up to World War 2 the Showground was used by the sixth Lighthorse Troops for training camps. During the 1939 camp, filming of the movie "Forty Thousand Horsemen" directed by Charles Chauvel was produced. One of the main actors was "Chips" Rafferty whose father, John Gaffage, had the License to Courthouse Hotel, (1917) & Oriental Hotel (1920), both orange hotels.

1941 In 1941 the Orange Showgrounds was officially taken over by the Commonwealth of Australian Defence Department with Army troops moving onto the site for the duration. The Showground was used as an Internment camp for Italians enemy aliens as opposed to Prisoners of War. They had been living in Australia for years.

1947 First show following the end of the war.

1952 The first rodeo was held on the Orange Showgrounds after timber rodeo yards were constructed by Mr. Mark Sweeting on the northern side of the then ring

1969 Orange's 100th Show was held on the present site. The show was opened 25th April 1969, by Her Majesty Queen Elizabeth's representative the British High Commissioner Sir Charles Johnson.

1985 A night show was held for the first time with sideshow alley all lit up. Saturday night fireworks were to be the new feature at the Orange Show. Work on the grounds included relining and painting the agricultural Pavilion, as well as replacing the ceiling in the Dalton Pavilion and the trotting track had been resurfaced with cinder.

1988 The Orange Show this year was awarded a N.S.W. Bicentennial certificate for their Orange Australian Bicentennial Show held in April 1988. This also marked the year that the National Trust listed the Orange Showground site and put it on the Heritage List.

No Show **1991-1994**

1995 This year marked the return of the regular Orange Show after a break of several years. The cupolas which were on top of the Grandstand were saved in 1995 also marked the year when the Orange Council unfortunately demolished the grandstand with little or no intension of replacing it. The cupolas which were on top of the Grandstand were returned to the Show Society (at a cost of \$500) and have been incorporated onto the Showground Entrance Gates.

2007 Rain during the night split the showground after floodwater flowed through the showground.

2019 Orange Show was featured on Better Homes and Gardens (Channel 7) The Naylor Pavilion was officially opened.

2022 The 150th Orange Show

ORANGE MISS SHOWGIRL/SHOW GIRL/YOUNG WOMAN

The “MISS SHOWGIRL” competition was first held at Orange Show in 1962 and was coordinated by Mrs Miriam Williams. Since its inception there have been two name changes, in 1999/ to “SHOWGIRL” and in 2023 to “YOUNG WOMAN”. Orange has twice held the regional judging for Zone 6 in 1999 and again in 2023. Orange has had three representatives win selection to attend the judging at the Royal Easter Show. In 1963 Dianne Scott and in 1983 Jennifer Wansey travelled to Sydney. More Recently 2024 Paris Capell has been selected at the Zone finals held in Narromine to represent the zone. We wish Paris well.

The Orange Show continues to be part of the Community and we look forward to our 175th Show, but to do this we will need many more volunteers and supporters.

DUTIES OF EXHIBITORS, STEWARDS AND JUDGES.

EXHIBITORS:

1. Exhibitors, when entering exhibits, must furnish the Secretary with description of the exhibit and the number of the class.
2. Exhibitors must obtain entrance cards from the Secretary, affix to exhibits and deliver to the Steward of the section at or before the hour advertised.
3. Exhibitors must present the duplicate portion of the entrance card to prove ownership of the exhibit prior to the article being returned.
4. Exhibits must not be removed without permission of the Steward.
5. Exhibitors of stock must have an attendant to parade same at hour notified.
6. No exhibitor of livestock shall be permitted to use any pen or stall other than those allocated to them by the Steward.
7. If demanded by the Committee, any exhibitor must furnish statutory declarations

STEWARDS:

1. Stewards must be in attendance at the Showground at the hour appointed to receive exhibits.
2. Stewards are responsible for the proper classification of exhibits and all exhibits must be ready to judge.

3. An exhibits suffering from an infectious or contagious disease shall be immediately reported to the Secretary, who is authorised to order its removal.
4. Stewards will obtain the award books from the Secretary and direct the Judges to the exhibits they are appointed to judge.
5. Stewards shall remove exhibitors and other persons from the vicinity of the Judge while judging.
6. Stewards will attend on the Judge to afford any information required, but will not do or say anything to influence his/her decision. They must not reveal the name of the exhibitor or repeat the remarks the Judge may make.
7. Stewards: will obtain prize cards from the Secretary and affix same to exhibit after filling in the name of the successful exhibits and other particulars.
8. Any sponsorship or money collected under the Orange Show Society Inc. banner remains the property of the Society.

JUDGES:

1. Judges are requested to attend the Secretary's office on the showground at the hour appointed, and introduce themselves to the Secretary and the Stewards of the relevant Section.
2. Judges will receive instruction from the Stewards of the Section.
3. Judges, as they arrive at their decisions, will announce the results to the Stewards, who will record them in the Award Book.
4. Judges shall disqualify any exhibits which, in their opinion, does not comply with the regulations, and shall enter the reason the Award Book.
5. The Judge may recommend for certificates, or commend as they see fit, any exhibits of special merit not included in the schedule of prizes, and will not award prizes of any class in which the exhibits are not considered, in their opinion, to possess sufficient merit.
6. Judges will check the Award Book on completion of Judging, and sign his/her name on the last award page.
7. Judges may, in addition to awarding First and Second prizes, award Highly Commended, to exhibits which they consider worthy.

** Note: Official closing time Pavilions Saturday 9pm 11th May
 Sunday 4pm 12th May.

REGULATIONS:

The prizes will be awarded subject to the appended Regulations and Conditions.

1. All entries except ring to be made in writing and lodged with the Secretary on date to be advised.
2. The Committee reserves the right of refusal or cancellation of any entry without giving any reason for doing so, and of accepting late entries.
3. Exhibitors of farm produce, flowers, fruit and vegetables must be the growers; and the makers of jams, jellies, preserves, fruits and

- the manufactured products only will be entitled to receive the prize. Fine Arts exhibits must be the work of the Exhibitor.
4. Exhibits entered for the Society's prize may compete for private prizes also, provided they are properly entered and ticketed.
 5. Any exhibitor known to have knowingly made false entries for a prize, or to have wilfully infringed any of the Rules, will render him/herself liable to be judged ineligible by the Committee for receiving any prize.
 6. Any person guilty of improper or insulting behaviour at any time towards the Committee, or any member thereof, any steward or official, in relation to their official duties, may be disqualified or suspended for such a period as the Committee see fit, or may be expelled from the Society. Any Exhibitor guilty of a breach of the rule may, at the discretion of the Committee, be disqualified from the exhibition for any period, or may be expelled from the ground.
 7. All exhibits must be properly placed and ticketed before advertised time of judging of exhibits, unless altered by special request of the Stewards or judges. No Exhibit can be removed before 4.00pm on the last day of the show without the express permission of the Steward.
 8. All persons who, after entering exhibits (especially of stock), are unable to exhibit same, will be expected to give notice to the Secretary of the inability to exhibit at least three days before the first day of the show.
 9. Any Exhibitor bringing an exhibit to the ground, and wilfully failing to exhibit it shall be liable to disqualification at the discretion of the Committee.
 10. No award ribbons, other than those awarded at the show, shall be placed on any exhibit whilst on the Showground without the consent of the steward.
 11. The Society will not be responsible for any accident that may be caused to or by exhibits, and will not, under any circumstances, be responsible for any loss or non-delivery of livestock or other exhibits of any kind, or for any injury done thereto. Stallions will not be allowed to compete in the buggy horse, hackney or pony classes.
The exhibition will take place on the Society's ground or where the Committee may appoint. The Committee reserves the right to, at any time, postpone the exhibition or any event thereof in consequence of the weather, or for any other sufficient cause, to a date or dates deemed suitable by the Committee, and no entrance fee shall be returned in the event of such postponement. The reasonableness of the cause of causes for postponement shall be decided by the Committee and not open to question by any exhibitor or persons affected by such judgement.
 12. In the event the Committee abandons or cancels the exhibition, or part thereof, through wet weather or any other reason which may make such course advisable, Exhibitors shall be entitled to a return on their entrance fees, but no cause for action, liability or obligation shall be maintainable, or be incurred, by the reason of such abandonment or cancellation.
 13. All persons exhibiting shall accept the decision of the Judges appointment by the Committee of the society, and on all protests the decision of the said Committee shall be final and without appeal.
 14. All protests must be delivered to the Secretary in writing before 4pm on the last day of the show, accompanied by a \$50 fee, which will be forfeited, if the protest is deemed frivolous. It shall be the duty of the person protesting to produce evidence in support of his/her allegation.
 15. The Secretary will distribute all prizes within one month after the show upon application. Any prizes unclaimed after 14 th June will revert to the Society.
 16. No prize money will be payable unless the original prize voucher, duly authorised, is produced, together with receipt for paid entry fees.
 17. Any exhibit having been awarded a prize at the last show without competition will not be entitled to a prize at this show unless there is competition. This regulation does not apply to District exhibits.
 18. Any person disqualified by the Board of Appeal (Royal Agriculture Society of NSW) will not be allowed to exhibit or take part in this show in any capacity whatever. In the event of any entry of Exhibitor having been disqualified by an Association, the Committee shall have the power to decide whether such entry or Exhibitor shall be allowed to compete.
 19. Show membership: Life Member \$200 Annual Membership \$30.00 Junior Membership \$8.00. No person, whether in charge of exhibit or not, will be admitted to the ground without a ticket. Passes will not be issued to the general public on any day of the show. Vehicles conveying exhibits to the ground will be admitted to the ground, but must leave the ground as soon as unloaded, or when required to do so by Steward.
 20. No collectors will be authorised on the ground excepting those authorised by the Committee to collect; any person infringing this regulation may be removed by any member of the Committee, with or without police assistance.
 21. ALL PERPETUAL TROPHIES must remain in the custody of the Society. Where awarded, any replicas, or payment of monies in lieu of it, will be retained by the recipient.
Due to several complaints in recent years, the running of raffles other than those run for Orange Show Society will not be permitted under any circumstances.

OVERVIEW

The Cattle Health Declaration is a legal document. Please complete accurately before signing.

Cattle Health Declarations are a way for producers to provide information about the health status of the cattle they are selling. Buyers should ask vendors for a Declaration and use the information provided to determine the health risks associated with the animals on offer.

Some states/territories require testing or certification additional to that outlined in this document e.g. Johne's disease (JD) in WA and for Enzootic Bovine Leucosis (EBL) in Tasmania. Please check the entry requirements for any interstate movements at:

www.animalhealthaustralia.com.au/what-we-do/endemic-disease/livestock-movements

The original of this form is to be attached to the National Vendor Declaration (NVD) form accompanying the cattle, if applicable. A duplicate remains with the vendor; it is recommended the vendor retains a copy of this declaration for seven (7) years.

TREATMENTS & VACCINATIONS

Provide details on any cattle treatments in the last six (6) months and vaccinations within the last twelve (12) months.

Some manufacturers include more than one of the categories listed in the same vaccine, known as a combination vaccine. If you use a combination vaccine, each agent(s), as appropriate, should be detailed.

For vaccinations to be current, you must have followed the manufacturer's recommendation for vaccination. Typically, young animals or first time vaccinated animals need two (2) doses, followed by annual boosters. Terminal 'T' tag lambs – lambs which are to be slaughtered before they cut their first permanent teeth and are identified by an NLIS (sheep) 'T' tag.

Tested low level Infected flock – an infected flock which has a history supporting a low level of infection, an approved Property Disease Management Program in place, and the most recent flock profile demonstrating a detection rate of not more than 1 of 7 pools by Pooled Faecal Culture within the previous 2 years. Sheep mobs that contributed to the positive pool are not eligible for this point.

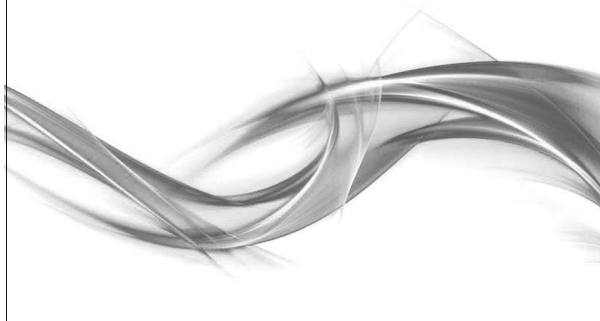

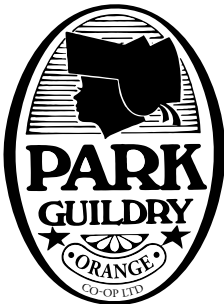

- 28 Agree not to make any claim against any Agricultural Show Society of NSW for any injury or loss sustained at any Agricultural Show.
- 29 Agree that he/she/they will compete/exhibit at my own risk and to indemnify and keep indemnified any Agricultural Show Society, together with any other organization or person involved in the conduct of any show against any claims, suits, actions or demands which may be bought in respect of any injury or other loss sustained by me in the course of competing/exhibiting at the show and agree to exonerate the committee of management of the show society together with any other organization or person involved in the conduct of any agricultural show from all loss or injury to he/she/they whether due to alleged negligence or otherwise.
